**Directions:** Exit the 10 Freeway at Cedar Ave. Go south on Cedar and turn west on Santa Ana Avenue. Go 0.8 miles to the clubhouse. It's the yellow building on your left between Maple and Locust.

These trials will be held indoors in the Orange Empire Kennel Club clubhouse. We will begin setting up the ring after 7:00 am on Saturday morning. The ring will take up most of the indoor space so crating will be on the cement outside the clubhouse. Exhibitors may enter the grounds and setup crating at 9:00 am on Saturday and at 8:00 am on Sunday. DCSAV will provide shelter as needed.

There is plenty of day parking at the clubhouse, but no overnight RV parking.

**Food:** Lunch will be provided on Saturday for judges and stewards. Shopping and fast food can be found at the Vineyard Valley Center at Sierra Ave (the exit west of Cedar) and Santa Ana Ave.

**Moveups:** Dogs which according to their owners records have earned an obedience or rally title after the closing of entries for the show may be moved up to the next class, provided this transfer is made in writing and presented to the Secretary at least 30 minutes prior to the start of each trial.
